## Why?

Financial companies choose how they share their personal information. Federal law gives consumers the right to limit some, but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

## What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social security number and information we receive on an application for credit;
- and information about your transactions with us and others;

• and information we receive from a credit reporting agency.

When you are no longer our customer, we continue to share your information as described in this notice.

## How?

All financial companies need to share nonpublic, personal information to run their everyday business. In the section below, we list the reasons financial companies can share their nonpublic information; the reasons 321 Auto Mart, chooses to share; and where you can limit t this sharing.

How does 321 Auto Mart protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We restrict access to your personal information to only those employees who need to know that information to do business.

Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit only:</li> <li>sharing for affiliates' everyday business purposes, such as information about your creditworthiness</li> <li>affiliates from using your information to market to you</li> <li>sharing your nonaffiliated to market to you.</li> <li>State laws and individual companies may give you additional rights to limit sharing.</li> </ul>
